Earlier Requisition Order by MC, AMC, Under The Epidemic Diseases Act, 1897, Dated- 16/05/20,

2. Hon'ble High Court, Gujarat, oral order Dt. 14/05/2020, 20.05.2020 and common oral order dated 29.05.2020 in PIL no 42 of 2020.

By earlier Requisition Order of MC, AMC, under The Epidemic Diseases Act, 1897, Dated- 16/05/20, private hospitals were designated as COVID-19 Hospitals for isolation of the cases for COVID-19 for Ahmedabad Municipal Corporation. By this order, the private hospitals designated as COVID-19 Hospitals were supposed to provide 50% of the total numbers of Beds in such hospitals for patients to be referred by AMC and for rest 50%, patients to be admitted and treated privately on their own. The Schedule of rates for both these categories were prescribed in Annexure-2 of the said order of 16.05.2020.

Further, as per Hon'ble High Court, Gujarat, Common oral order Dt. 29.05.2020 in PIL no 42 of 2020, again the schedule of rates for both categories have been reduced, and after reduction of 10% in ceiling rate per day for private beds (B category) for Ward & HDU and 5% for 2 categories (1) Isolation + ICU and (2) Ventilation + Isolation + ICU, the new revised rates for both these categories will be as under.

Above Rates for both category (A) and (C) includes Two Meals, Breakfast, Evening tea and snacks. (3)

There shall be no difference in the quality of treatment being meted out to either of the category patients (4)

These rates will come in to force with effect from Requisition order dated -16.05.2020.
